- Legal Practitioners /Litigants are to take note of the allocated time for the hearing of their matters.

Legal Practitioners /Litigants will be allowed into the court building 5 matters at a time.
- When Legal Practitioners /Litigants in a matter are finished, he/she will exit the courtroom and immediately exit the building.
- Urgent matters will be dealt with after the roll or by another Court.
